Global level



- Push for a collective answer to the current multi-crisis situation based on a dialogue between all actors
- Integrate the socio-cultural aspect in the circular transition insisting on sufficiency and inclusiveness and questioning our needs and consumption patterns
- Reinforce Euro-Med cooperation on local action plans and local policy design

Main activities:

- Organised several working groups on governance on topics such as the governance and financing challenges for circular bioeconomy (the BIOTRANSFORM project), supporting the production and use of alternative fertilizers (the Fer-Play project), circular resource management and circular systemic solutions (CCRI-CSO), and leading the Region and Cities Advisory Panel (H4C)
- The 15th edition of the European Week for Waste Reduction meets with success as 14 522
 actions took place in 29 countries thanks to the support of 35 coordinators. The theme selected
 for this year was "sustainable packaging" reinforcing messages on sustainable consumption
 (and prevention).
- Following its objective of reinforcing Euro-med cooperation, ACR+ supported the first edition of the Euro-Med Weeks for Waste Reduction, acknowledging the work carried out by the five winning actions from Tunisia, Algeria, Israel and Jordan.
- To accompany the Mediterranean region in its circular transformation, ACR+ is active within the Interreg Euro-MED Innovative Sustainable Economy mission and contributed to several activities such as the Interreg Euro-MED Event "Connecting the Dots: The Path for a Smarter and Greener Mediterranean" in November.
- To "show by example" that it is necessary to work together, ACR+ collaborated with several intiatives or organisations (and not only representing public authorities) such as the Circular Plastics Alliance, Close the Glass Loop, Interreg Europe, etc. This led to the co-organisation of events (e.g. webinar with the European Space Agency on littering), the participation as speaker in conferences (e.g. webinar of the Interreg Europe Policy Learning Platform "Leading the way towards waste prevention"), or the publication of papers and manifestos.

European level

• Build a strong advocacy action on waste prevention targets

Main activities:

- ACR+ monitored and updated its members about EU policy development and implications for local and regional authorities. It also shared the voice of local authorities in several key files such as: the Packaging and Packaging Waste Regulation, the revision of the EU Waste Framework Directive regarding the environmental impact of waste management, the Soil Monitoring and Resilience Directive
- We shared with the European Commission an <u>open letter</u> including few concrete measures that could help the future Commission to better address decentralised authorities' needs and provide them with the right instruments and support, considering their specificities and local contexts.
- We joined a coalition in support of Packaging and Packaging Waste Regulation and endorsed a position paper on packaging reuse, which represents the collaboration of various stakeholders.
- We reviewed the European Commission's proposal for the new Soil Health Law, providing comments on the draft text of the law, and distributed the document to the ENVE committee of the Committee of the Regions to facilitate an informed discussion at the regional and city levels across the European Union.
- Publication of the results of Belfast in the framework of our campaign More Circularity, Less Carbon
- Focus on the circular textile management through the work of the CISUTAC project, the publication
 of the report "Recommendations and good practices for local used textile management", the
 participation in a policy roundtable of the New Cotton project on collection and sorting of postconsumer textiles, a TAIEX workshop dedicated to textile waste separate collection, treatment and
 markets, and the Global Fashion Summit 2023, as well as the co-organisation with the EBCD of a
 conference on EPR and textiles.
- Focus on financing schemes for circular economy initiatives within local and regional public authorities through the DECISO and HOOP projects.
- Focus on bioeconomy and biowaste management, in particular indicators and strategy, through several activities of the projects LIFE BioBest, FOLOU, Biocircularcities. In addition, the development of the HOOP Network of Cities and Regions gave access and direct contact with other territories and HOOP experts on biowaste management and innovative recycling routes with several webinars and study-visits organised throughout 2023.

ACR+ level

- Strengthen knowledge exchange and support members on sustainable energy and material resources integrated policies
- Adapt to a growing network (members, team, topics, data) and need for expertise

Main activities:

- Annual General Assembly on 31 May-1 June in Dublin, hosted by the Eastern Midlands Waste Region in parallel to the Circular Economy Hotspot and the EWWR Awards Ceremony. Keynote speeches (Cillian Lohan from the European Social and Economic Committee, Sergio Pérez García from the government of Navarra, and Joan Prummel from Rijkswaterstaat) and interactive discussion groups highlighted the importance of continuing to work hand in hand to achieve a truly circular transformation. During the interactive session, ACR+ members exchanged on the five working themes that have been adopted at the beginning of the year: Built Environment, Sustainable Food Systems, Circular Lifestyles, Policy and Governance, and Waste and Material Flows. For each theme, they shared their vision, their current activities, and how the network can further support them.
- Support to members by assessing local and national waste management plans (Brussels Environment (BE), Connacht Ulster Waste Region (IE), Eastern Midlands Waste Region (IE), Southern Waste Region (IE))
- Acquisition of a new CRM system to facilitate data management, improve members' experience, ease the exchange of information
- Moving to new offices
- Our strategic partnership with Energy Cities came to life with the organisation of several joint meeting with Energy Cities members, and our presence at their General Assembly in Modena

Recommendations and Good Practices for Local Used Textile Management

This report offers a detailed analysis and benchmark of current European practices, tips and recommendations on how to manage textile waste, and overall guidance for public authorities to get prepared for the upcoming obligation. It includes five key recommendations:

- Establish a local governance on textile management
- Strengthen existing collection methods, and identify alternative collection methods
- Promote textile waste prevention and second-hand buying
- Extend sorting instructions only when an EPR system is available
- Support circular tenders for professional textiles

The Carbon Footprint of Waste of Belfast

This report assess the carbon footprint of household waste of Belfast using the Carbon Metric International tool (amounting to 360 000 tCO2eq in 2020). Based on the analysis, the report suggests scenarios to reduce this footprint by 90 000 tCO2eq by 2025 and achieve the 25% reduction target of the ACR+ 'More Circularity Less Carbon' campaign. The efforts should focus on the most carbon-intensive fractions, namely reducing textile and food waste and increasing plastic recycling.

Deposit Refund Systems in the EU - 2023 Update



Five years after a first report on Deposit Return Systems for single use packaging, this new report emphasises changes at both the Member State and EU levels. It focuses on fourteen Member States with existing DRS and provides updated data, exploring the effectiveness of deposit systems in reducing littering, and delving into their interaction with Extended Producer Responsibility schemes. The study also incorporates publicly available information on system results.

The report focuses on contributing to the broader discussion surrounding deposit systems, examining their potential and limitations in addressing critical issues like waste reduction and plastic pollution.
