## **Commission Proposal**

- To solve technical, legal, and administrative problems which lead to unintended costs and burden on market actors
- To set higher targets for collection and recycling.



#### Problems to be solved

- Too little WEEE is reported to be treated according to legislation.
- Illegal trade is still widespread.
- Material resources are lost; best recovery options are not used.
- Improper treatment results in environmental damage and health risks



## What changed?

#### **Considerations**

- Less emphasis on reuse and design for recycling.
- Specific attention to CFC containing devices
- Member states should encourage producers to finance total collection



#### Finance of collection

"Member states should encourage producers to take full ownership of the WEEE collection in particular by financing the collection of WEEE throughout the whole waste chain, including from private households, in order to avoid leakage of seperatly collected WEEE to sub-optimal treatment and illegal exports, to create a level playing field by harmonising producer financing across the EU, to shift payment for the collection of this waste from general tax payers to the consumers of EEEs in line with the polluter pays principle."

Article 1: Objectives

- Article 2: Scope
  - Refers to RoHS
  - Clarification on excluded appliances
  - Comitoligy decision on categorisation of B2B versus household aplliances.
- Article 3: Definitions
  - Aligned with WFD



#### Article 4 - 7

- Article 4: Product design
  - Reuse added
- Article 5: Seperate collection
  - Specific attention for CFC containing devices
- Article 6: disposal and transport
  - Previous in article 5
- Articel 7: collection rate
  - Relative rate of 65% of sales
  - Possible seperate target for CFC devices from 2012



#### Article 8 - 10

- Article 8: treatment (previous: 6)
  - New wording refering to BAT and Annex II and III.
  - Annex II to be amended through comitoligy decision.
  - Special attention for treatment of printed circuit boards from cell-phones and LC-displays.
- Article 9: Permits and inspections (previous in 6)
  - Reference to annex III for storage and treatment moved to article 8
- Article 10: Shipments of WEEE (previous in 6)
  - Reference to EMAS moved to article 8.
  - Criteria for assesment of "equivalent conditions" to be decided through comitology procedure



#### **Article 11 - 14**

- Article 11: Recovery targets
  - All targets raised with 5%
  - Reuse included in recovery targets
- Article 12: Financing WEEE from households
  - Visible fee may stay
- Article 13: Financing commercial WEEE
  - No real changes
- Article 14: Information for users
  - Visible fee may be shown



#### **Article 15 - 18**

- Article 15: Information for treatment
  - No real changes
- Article 16: registration, information, reporting
  - Producers may register and report in just 1 country for the whole EU
  - Format for registration and reporting to be astablished
  - Member states report three-yearly to Commission
- Article 17: adaptation to progress
  - No real changes
- Article 18: Committee
  - No real changes



#### **Article 19 - 23**

- Article 19: penalties
  - Stronger and more precise wording
- Article 20: Inspection and monitoring
  - Special emphasis on monitoring of shipment of WEEE with reference to new Annex I
  - Additional rules on inspection and monitoring to be laid down through comitology procedure
- Article 21: transposition
- Article 22: Repeal
- Article 23: Entry into force



#### **Annexes**

- New Annex I: Monitoring requirements for shipment of WEEE
  - Rules to distinguish between waste and reusable equipment:
    - Copy of invoice
    - Evidence of evaluation or testing
    - Declaration of the holder
    - Sufficiant packaging
- Annex II, III and IV
  - No real changes
